ACES Overview

Admitted Class Evaluation Service™ (ACES) is a free online service for higher education institutions that predicts how admitted students will perform at your institution generally and how successful they can be in specific classes. ACES helps you answer important questions about the assessments you use to admit and place students at your institution.

Year-Over-Year Study Overview

Inform your admission decisions with a customized report that tracks the relationships between different predictors, including SAT® scores, and student performance at your institution over time. Trends for students from different entering cohort years and their progress at your institution (academic year) are presented.

Unlike other ACES studies, Year-Over-Year SAT Admission Validity Studies (hereafter referred to as Year-Over-Year) are based on student datasets previously submitted and processed from earlier SAT Admission Validity Studies (see [SAT® Admission Study Guide](#)) or “Data Only” submissions (for participation in the College Board’s National Validity Study). For this reason, unlike other ACES studies, you will select student datasets to be included in the Year-Over-Year study instead of uploading new student data files.

If your institution has not previously submitted studies in the ACES system and you wish to request a Year-Over-Year study, you will need to first submit SAT Admission Validity Studies for students in the entering cohorts and academic years of interest (see [SAT® Admission Study Guide](#)) and then, after those studies have been processed, request your Year-Over-Year study.

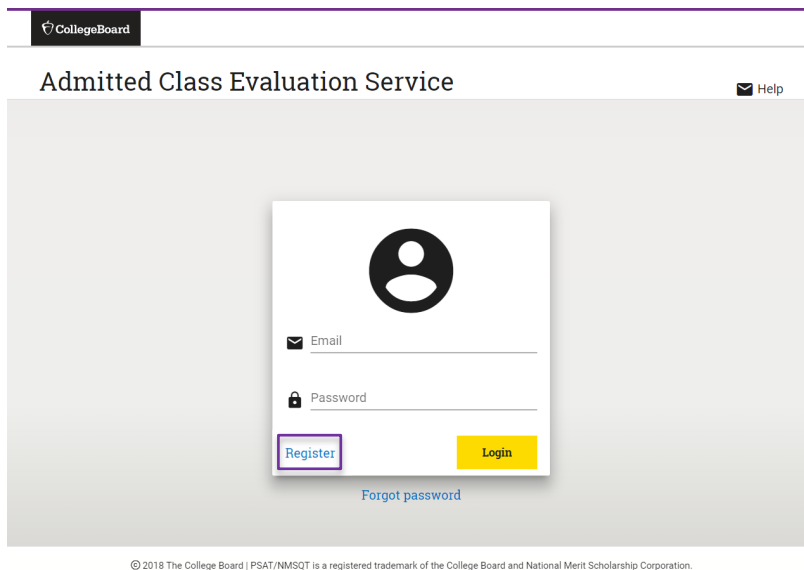
Submission Overview

Your first step will be to register for an account with ACES. [If you have not done so previously.] You will then design your study.¹ Before finalizing your study, if not previously done, you will be required to sign the data sharing agreement on the ACES portal. Your data sharing agreement will be valid for two years. Once your agreement is signed and your study is complete, you will be able to submit your request. You will be notified via email when your report is ready.

Getting Started – Account Registration [If not previously registered]

1. Navigate to <https://acesportal.collegeboard.org>.
2. Click “REGISTER” on the login page.

¹ Be aware that Year-Over-Year Studies use data from previous ACES study submissions (typically Admission Validity Studies). So if your institution has not submitted ACES studies in the past, you would need to submit ACES Admission Validity Studies in order to support a Year-Over-Year analysis.



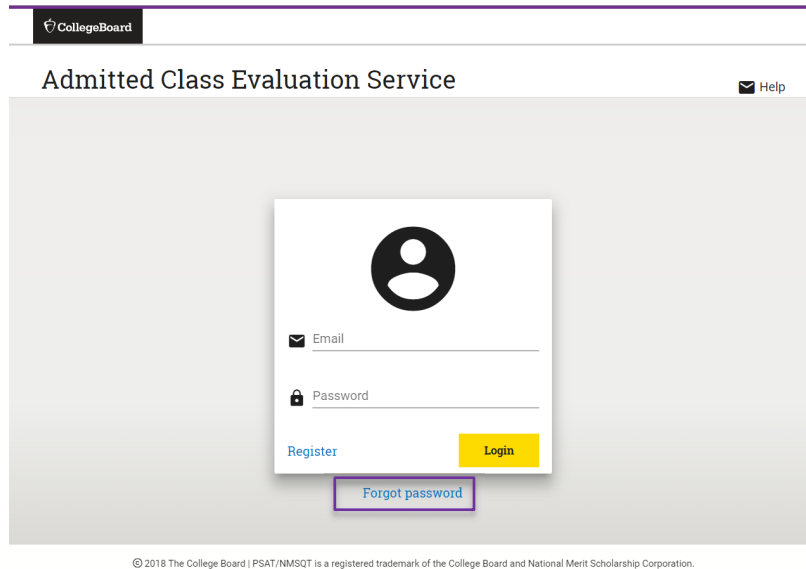
3. Fill out the appropriate information (name, title, email, phone number, and institution (drop-down menu)).
 - *Email*: Must be a .gov or .edu address.
 - *Institution*: If you are from a university system, not one specific institution, please select “Education System Office” and type in the name of your university system in the box provided.

4. Click “REGISTER.”
5. Upon registering, an “Account created!” message will appear.
6. Within a few minutes, you should receive a confirmation email.
 - Please check your spam/junk folder if you do not see your confirmation email in your inbox.

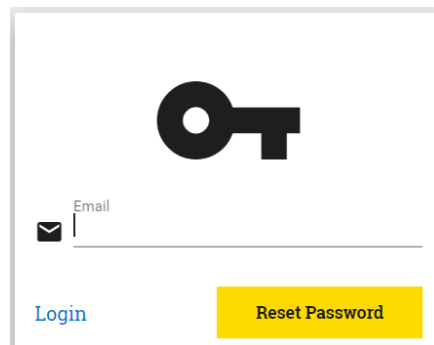
7. Click on the link within the confirmation email to activate the account and create a new password.
- Your password must be at least eight characters and contain at least one number, uppercase letter, and symbol (!, ?, @, *).

Password Reset

1. Click on “FORGOT PASSWORD” on the login page.



2. Enter your registered email address.



3. Click on “RESET PASSWORD.”
 4. Open password reset link via email.
 5. Create and confirm a new password.
- Remember your password must contain at least 8 characters, at least one number, one uppercase letter, and one symbol.

6. Login with your new password.

Logging In

1. Navigate to the login page: <https://acesportal.collegeboard.org>.
2. Enter your registered email and password.
3. Click “LOGIN.”

Create a Study

1. From the home screen, navigate to the “New Study” section.
2. Select “Year Over Year SAT Admission Validity Study.”
 - a. When you request a study for the first time, you will be prompted to choose whether you are a two year or a four year institution. You will only need to indicate this information the first time you use the system as it will save your choice for future study requests. [Note: this step was likely completed during earlier ACES submissions.]

- > SAT Admission Validity Study
Inform your admission decisions with a customized report, predictive models, and matched file that help you understand the relationship between different predictors, including SAT scores, and student performance at your institution.
- > ACCUPLACER Placement Validity Study
Evaluate how performance on ACCUPLACER tests, taken prior to enrollment in a course, relates to student performance in that course in order to validate and improve placement decisions. Note that at least 30 students with the ACCUPLACER score and course grade of interest are required for this study.
- > SAT Placement Validity Study
Evaluate how performance on the SAT relates to student performance in introductory coursework in corresponding domains, in order to validate and improve placement decisions.
- > AP Placement Validity Study
Evaluate how performance on AP Exams relates to student performance in sequent and subsequent courses, in order to validate and improve credit and placement policy decisions.
- > Retention Study
Evaluate a selection of relevant predictors and the likelihood of students returning to your institution, as well as identify those at high risk for not returning.
- > CLEP Placement Validity Study
Evaluate how performance on CLEP Exams relates to student performance in sequent and subsequent courses, in order to validate and improve credit and placement policy decisions.
- > **Year Over Year SAT Admission Validity Study**
Examine trends in entering cohort descriptive statistics and predictive relationships (e.g. SAT scores, HSGPA, etc., with college GPA) over time, within and across student cohorts.
- > Completion Study
Evaluate a selection of relevant predictors and the likelihood of students completing a degree at your institution, as well as identify those at high risk for not completing a degree.

3. Select previously submitted student data that you wish to compare in this Year-Over-Year study.

The ACES system will retrieve previous data submissions (typically from Admission Validity Studies) and present those eligible for inclusion in the Year-Over-Year Study. The list of eligible files/studies will be ordered by entering cohort year and then by academic year (First year, Second year, etc.). At least two previous submissions must be available in order to request a Year-Over-Year Study.

If there is only a single eligible submission for students from an entering cohort year and academic school year, you can select it for inclusion. If there are multiple studies submitted for a particular entering cohort year and academic year combination (the number of eligible studies will be listed next to the academic year), you can then select which study to include in your Year-Over-Year report.

Note: Only earlier submissions made by you will be listed. If someone other than you in your institution/educational system submitted earlier studies, either they can make the Year-Over-Year Study request or they can contact ACES (aces-collegeboard@norc.org) to request that the studies they submitted be made accessible to you.

4. Confirm the data to be included by selecting the Create button.
5. Create a unique study name (e.g., 2020 Year-Over-Year SAT Admission Validity Study) to help you identify your study and add optional secondary contact information to notify others when the study is complete (note that they will not automatically receive a copy of the study but will be informed that results are available).

6. You can verify the data sources for the study. Each data submission appears in a separate card identified by entering cohort year and academic year. To obtain more detail about any of these previous submissions, you can select the arrow icon in the lower right corner of a submission card, which will open a new window presenting the details of the submission.

7. Select high school GPA data source (supplied by your institution or using ACES-supplied data).

Note: The “Supplied by your institution” choice will only appear if all selected submissions included HS GPA values provided by your institution. You can examine details of the submissions to see which included HS GPA. If one of your submissions did not include HS GPA and you wish HS GPA supplied by your institution used in the Year-Over-Year Study, you can submit the original data with institution HS GPA as a new Admission Validity Study. Once that study is processed by ACES, the data submission will be available for your Year-Over-Year study.

8. Select the SAT score(s) to use as predictors. Choose either SAT Total or SAT ERW and Math Sections.

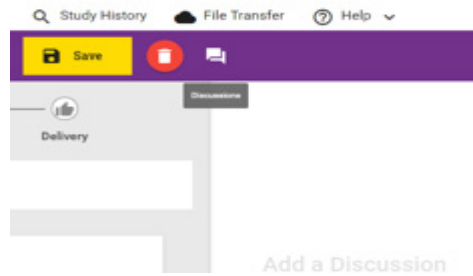

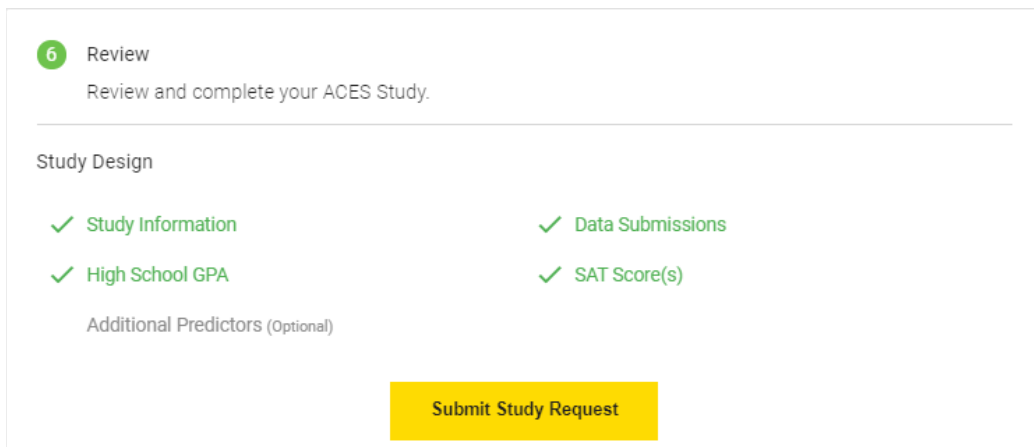
Note: These ACES database predictors are also available as predictors in Admission Validity Studies. You do not necessarily need to select the same additional ACES database predictors that you previously studied.

10. Review all information and ensure the Year-Over-Year Study design is complete. If at any point during the study design or data submission selection process you have questions or require assistance, you can use the “Discussion” feature at the top right corner of the screen and technical support will be provided.



11. You will be asked to save your submission before proceeding (see Save button in screen above). Then you will be able to submit your study request.

12. Select “Submit Study Request.”



13. You will receive an email when your study request has been reviewed and the analysis has begun. It will take approximately 20 business days to complete your study.

Check Study Request Status

1. Navigate to the home page to see an overview status of your recently submitted studies.
2. For information about previously submitted studies, navigate to the “Study History” tab in the top navigation bar.
3. Select the study to see the status. To filter the list, use the “Study Type” module on the left side.
